Entry, Pick up and School Visit Procedure

- Thermal Scanner at strategic points
- All students to wear masks at all times.
- Staff will be wearing face shields as well
- Only one family member or guardian to drop off the child at the designated area
- Two meters physical distancing in all corridors, classrooms and strategic entry and exit points
- Meetings with staff and parents encouraged online.

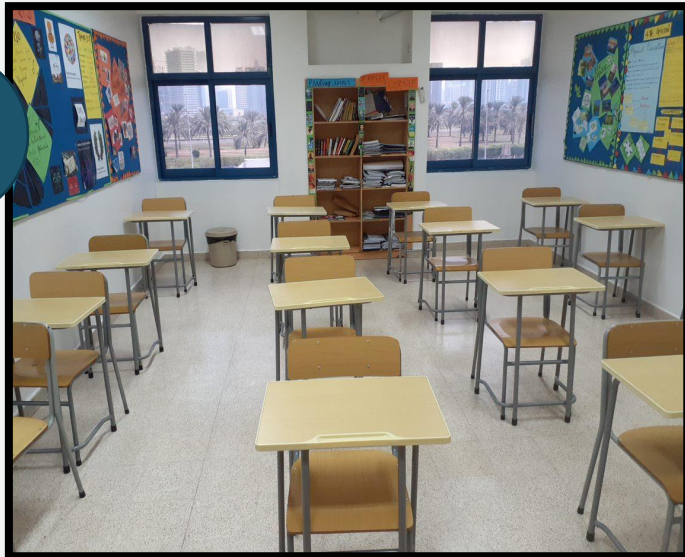

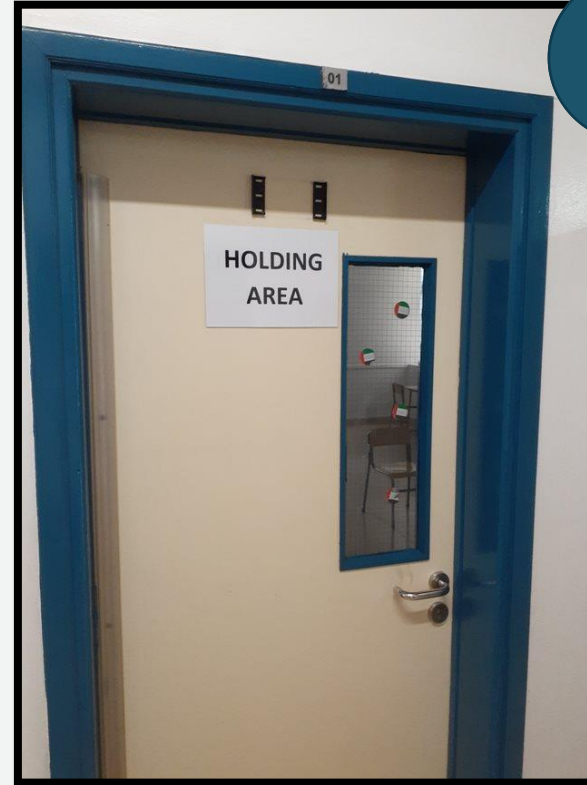

Monitoring Attendance and Contact Tracing

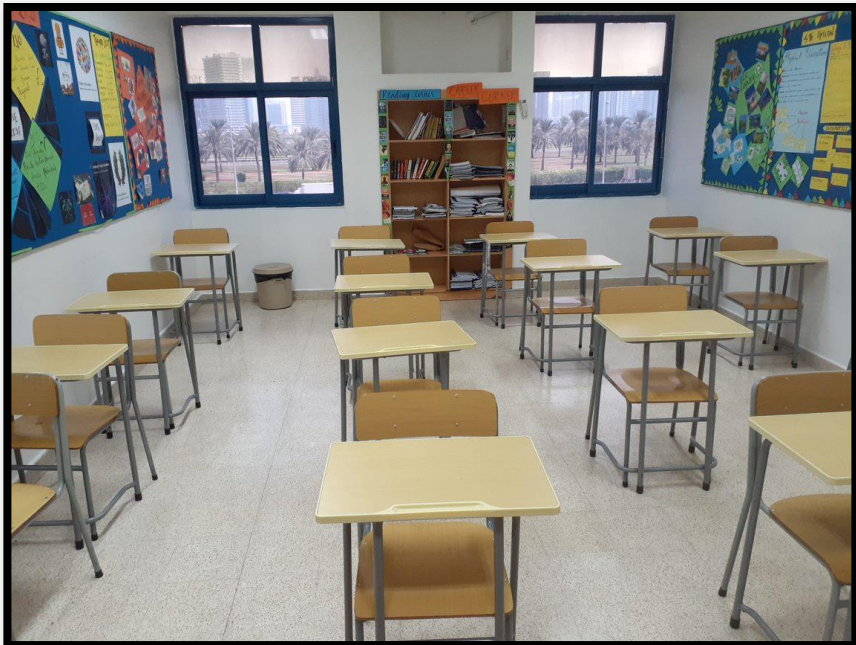
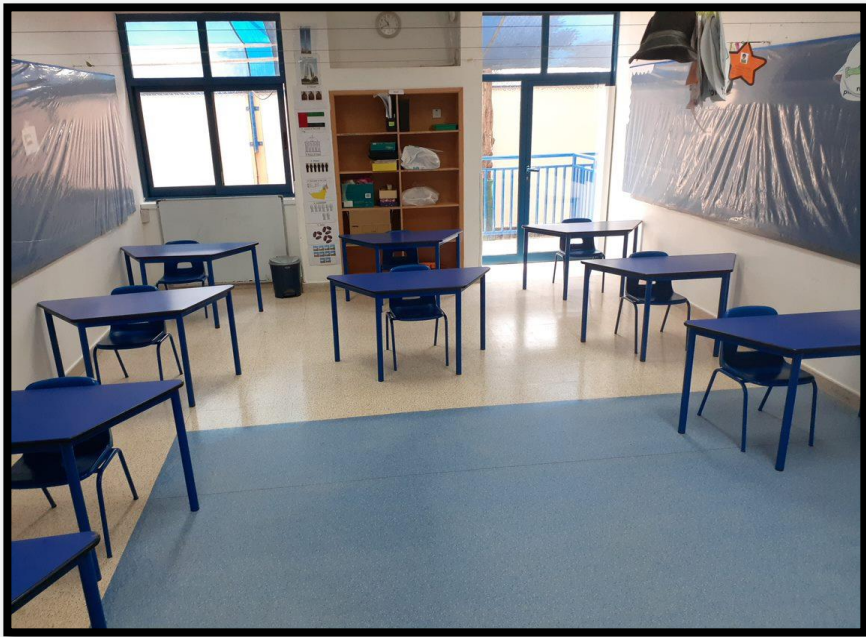
Regular Sanitizing of washrooms after every use

Physical Distancing Arrangements



- Created visible markers on the floor to indicate appropriate spacing (2mts)
- Staggered timing for washroom breaks
- Seating arrangements in classroom are at 1.5mts for every child
- Canteens closed, no water dispensers
- Staggered use of staff room/office/entry and exit to avoid overcrowding

Educational Provisions

- Regular eight period timetable will be followed.
- Four days of face to face class and one day of online class (on Thursday)
- Students will have a fixed table and chair in the classroom.
- Students will not be sharing any classroom resources – stationaries, devices, notebooks etc.
- Teachers in high risk category will teach remotely.
- Students will be allowed to visit outdoor play area during PE period. During this time, they need not wear masks
- All extra curricular activities will continue to be online.
